# **Legislative Background**

The Government of British Columbia is working towards being an inclusive province. There are over 926,000 people with disabilities in B.C. In June 2021, the Accessible B.C. Act became law. It provides a framework to identify, remove, and prevent barriers to accessibility. The new law is an important step to make B.C. a more accessible province.

Under the law, schools need to create an accessibility plan. The plan will be updated every three years. The committee will continue to provide advice to the government on this plan. The plan aims to look at the following guiding principles:

- 1. Inclusion
- 2. Adaptability
- 3. Diversity
- 4. Collaboration
- 5. Self-determination
- 6. Universal design

# **Guiding Framework:**

## The purpose of this plan is as follows:

- 1. Create a space that allows all students and visitors to feel accepted and welcomed.
- 2. Implement the necessary adaptations and accommodations to limit barriers to education and building accessibility to all visitors.

## **Accessibility Committee and Consultations to Date:**

SKY Secondary School's Authority Head, Principal, and Primary Teacher have worked together to create this comprehensive accessibility plan for the building and school community. The committee will grow as staff and students at the school grow. Committee members have preliminary experience and background knowledge in creating accessible spaces for their staff



and students. The committee at SKY Secondary school has conducted a visual inspection of the school and the main areas of use.
